## **GUIDELINES ON ACCEPTABLE FUNDABLE PROGRAMMES:**

### **1. Welfare and humanitarian**

- 1.1 The care or counselling of, or the provision of education programmes relating to, abandoned, abused, neglected, orphaned or homeless children.
- 1.2 The care or counselling of poor and needy persons where more than 90% (ninety per cent) of those persons to whom the care of counselling are provided are over the age of 60 (sixty).
- 1.3 The care or counselling of, or the provision of education programmes relating to, physically or mentally abused and traumatised persons.
- 1.4 The rehabilitation, care or counselling of persons addicted to a dependence-forming substance or the provision of preventative and education programmes regarding addition to dependence-forming substances.
- 1.5 The promotion of protection of family stability.
- 1.6 Community development for poor and needy persons and anti-poverty initiatives, including:
  - 1.6.1 the promotion of community-based projects relating to self-help, empowerment, capacity building, skills development or anti-poverty;
  - 1.6.2 the provision of training, support or assistance to community-based projects contemplated in paragraph 1.6.1 of this Annexure "1";
  - 1.6.3 the provision of training, support or assistance to emerging micro enterprises to improve capacity to start and manage businesses, which may include the granting of loans on such conditions as may be required by the Founder;
    - 1.6.3.1 the provision of legal services for poor and needy persons; or
    - 1.6.3.2 the provision of facilities for the protection and care of children under school-going age of poor and needy parents.

### **2. Health care**

- 2.1 The provision of health care services to poor and needy persons.
- 2.2 The care or counselling of terminally ill persons or persons with a severe physical or mental disability, and the counselling of their families in this regard.
- 2.3 The prevention of HIV infection, the provision of preventative and education programmes relating to HIV/AIDS.
- 2.4 The care, counselling or treatment of persons afflicted with HIV/AIDS, including the care or counselling of their families and dependants in this regard.
- 2.5 The provision of primary health care education, sex education or family planning.

## **CRITERIA FOR PROPOSAL EVALUATION** (based on the Trust's Projects Procurement Policy):

For Socio-Economic Development (SED) Beneficiary applications, the following information is mandatory to be considered.

- 8.4.1. Project rationale and background.
- 8.4.2. Implementing organisation founding CIPRO documents, constitution, and Trust Deed where applicable; organisation to be within the 50km radius of operation and compliant with the business laws of RSA.
- 8.4.3. Management profile, experience, and competencies
- 8.4.4. Completed project contactable references.
- 8.4.5. Statutory compliance
- 8.4.6. Latest signed financial statement
- 8.4.7. Related insurances if applicable
- 8.4.8. Project technical detail including problem statement and solution, beneficiaries, design elements of program with clear KPI, schedule of activities, outcomes, risks, and their mitigation.

8.4.9. Letters of external support for the project. Projects that have multi-partner funding are welcome.

8.4.10. Detailed project budget breakdown with sections to include technical, management, administration, and other costs. *The Trust does not fund an organisation's day to day operational costs e.g., salaries, water, electricity, rent, airtime/data.*

8.4.11. Project cashflow and tranche payment plan

8.4.12. A Competent Person's Report confirming that at least 85% of the benefit received will benefit Black people in the priority community, in accordance with Socio-Economic Development Contributions no. 36928, Department of Trade and Industry Gazette, 11 October 2013.

8.4.13. Project reporting framework

8.4.14. Project impacts - a minimum of 100 people in the communities; community problem resolved; key performance indicators achieved; number of local jobs created; local businesses that have benefitted.
